ASSIGNMENTS/DETERMINATION OF THE FINAL GRADE

The Final Grade will be determined by three Open Book/Take Home Essay Tests issued by email on the following Test Days: October 7, November 16, and December 9. Each test will be weighted as one-third of the Final Grade. These tests will cover the material discussed in lecture in the weeks before the test: Test #1 will cover The Classical Period (Greek and Roman Theatre), Test #2 will cover Medieval and Renaissance Drama, and Test #3 will cover French Neo-Classicism and the English Restoration/18th Century.

Each test will consist of two questions, asking for answers to be given in two essays of approximately 150-250 words each in length. The first question will deal with the physical playhouse and/or performance spaces of each era, while the second question will be about a play from the period that was assigned reading. The completed answers must be returned to me as a document attached to an email.

The test questions will sent by email to each student by 11AM of the Test Day, and will be expected to be returned to me as a document attached to an email by 1PM of the next day, giving students 26 hours to complete the assignment, which I expect will take most students only 2-4 hours of their time.
