Assessment components

Assignment 1: Director's Book

Assessment Method: Individual assessment

Description: students will create director's book including background research, text analysis, and a formal plan that are integrated under a specific vision for the work. Students will prepare a director's book for Shakespeare's *Hamlet* from which the directing assignments are drawn. Students will be asked to share their book with the class on D2L so we can all learn from one another. To support our work, we will use a free, online scholarly edition of the play (link) as our base text, and the instructor will provide a performance text students can use for their directing projects. (Note: finding your approach to the Director's Book takes time. Students will be able to revise their books throughout the term.) Detailed instructions provided in class.

Weight: 20%

Due Date: Sept 27, 2021

Assignment 2: Directing a Monologue

Assessment Method: evaluation of the use of directing fundamentals as introduced in class and used to develop a monologue. Evaluation will involve discussion between the instructor and student in order to review the work and discuss the student's future practice.

Description: students will direct the "To be or not to be monologue" from *Hamlet* using an approach designed for an online class; or, working in studio where possible (neither approach is preferred). Detailed instructions provided in class.

Weight: 30%

Due Date: Oct 11, 2021

Assignment 3: Directing a Dialogue

Assessment Method: evaluation of the use of directing fundamentals, development from first assignment work, and implementation / experimentation in the directing of a dialogue.

Description: students will choose a dialogue from *Hamlet* and direct a scene designed for sharing online or performed in person where possible. Detailed instructions provided in class.

Weight: 40%

Due Date: Nov 15, 2021

Assignment 4: Reflection

Assessment Method: review of directing fundamentals, analysis of emerging directing practice, and supporting materials drawn from the work of the other directors in the class.

Description: using the material from the earlier assignments, students will create a reflection describing their directing practice. The goal of the reflection is to capture the director's development, and to build a formal analysis of artistic process to support future work. Detailed instructions provided in class.

Weight: 10%

Due Date: December 6, 2021

Assessment expectations

<u>Guidelines for Submitting Assignments:</u> we will be working creatively to address challenges related to workspace. As creators, students are encouraged to be adventurous in their explorations, but gentle in their evaluation of others. We should expect mistakes that are more the fault of current conditions than of those

working together in the class. Wherever possible, students will be able to work in person, but choices on where or how to work should be based on the students' vision. Detailed instructions will be provided in class.

<u>Missed or Late Assignments:</u> late assignments are accepted with a grade deduction of 5% a day up to a maximum of 10%. All assignments must be complete by the final day of classes.

Expectations for Writing:
