Course description	In this in-depth exploration of the art of directing for the stage, we will investigate
	some of the tools directors use to tell stories in the theatre, both in theory and
	practice. We will focus on: the use of place and space; creating the physical score;
	language, text, and silence; and working with performers. Students will study,
	observe, learn, and put these tools into practice as directors, in a short scene and a
	monologue from the contemporary repertoire.

	witness; begin to use those tools yourself.
	2. Demonstrate basic familiarity with the roles and functions of the director, and
	awareness of the various approaches of some contemporary directors.

- 3. Identify and respond creatively to the expressive qualities of a space as a site for performance.
- 4. Work with collaborators to apply elementary knowledge of visual composition, physical relationship, blocking, and theatrical movement to create a physical score that tells a story to an audience.
- 5. Guide your collaborators in basic acting choices and interpretation, with increasing specificity, in a scene and in a monologue
- 6. Articulate awareness of your own artistic development; demonstrate the ability to apply theoretical learning to your creative practice; show evidence of growth in observational skills, and verbal and written articulacy about the process.

Assessment components

<u>Assignment 1</u>: Four in-class quizzes on discipline knowledge learned from readings. Assessment Method: self-graded; grade confirmed by instructor

Description: Four fill in the blank quizzes taking 10 minutes of on-line class time $\,$

Weight: 4%

Due Date: January 19, 26, February 2, 9, 2021. If student is absent, they score 0% on that guiz.

<u>Assignment 2:</u> Written analysis of how some of the directorial tools studied in class help tell the story in a professional theatrical performance viewable on-line.

Assessment: Graded by instructor

Description: You will select a professional theatrical performance, approved by instructor, and write a 750 word paper analyzing the use of the directorial tools of place and space and/or physical score and how those directorial choices contribute to the story-telling.

Weight: 15%

Due date: February 23, 2021

Assignment 3: Directing a scene

Assessment: Scene presentation graded by instructor on March 25, 2021; written scene preparation document graded by instructor upon submission.

Description: You will direct one five-minute scene for two people, observing all physical distancing protocols and guidelines. Your cast will be two (or three) classmates and you will work within that cohort. Three in-class rehearsals and three out of class rehearsals will lead to an in-class scene presentation. You will submit a written document recording your preparation to direct the scene, your process through rehearsals, and a summary of discoveries you made.

Weight: 35%, combined scene and written document.

Due date: Scene presentation March 25, 2021; written document April 1, 2021. Note: if you miss any of your own rehearsals or any you are cast in you without a valid health reason you will score 0 in the scene presentation component of this grade.

Assignment 4: Directing a monologue on Zoom

Assessment: Graded by instructor based on watching two sessions between director and actor on March 30 and April 3, 2021

Description: You will coach an acting student in a monologue of their choice, over Zoom, over the course of two sessions. You will need to read the play and prepare to direct. You will be assessed based on your ability to apply what we have learned and discussed in class about working with performers, and especially, on your responsiveness to the performer and growth from session to session.

Weight: 20%

Due date: March 30 (25 min appointment on Zoom) and April 3, 2021 (15 min appointment on Zoom)

Note: If you miss either of these two appointments without a valid health reason you will score 0% on this assignment.

Assignment 5: A final paper on your choice of several topics.

Assessment: Graded by instructor upon submission

Description: You will write a 1000 word paper on your choice of several topics to be assigned in class.

Weight: 20%

Due date: Monday April 20, 2021 (Monday after last day of class)

<u>Assignment 6:</u> Your contributions to artistic discussion and the exploration of ideas in class.

Assessment: Graded by the student; grade reviewed and approved/adjusted by instructor.

Description: based on a grading rubric distributed in class, assess your own contributions to artistic discussion and the exploration of ideas in class. Did you bring in new approaches and expand upon or deviate from consensus? Did you support and expand upon the good ideas of your classmates, when they were in danger of being overlooked? Draw links to other sources or previous discussions? Express or demonstrate originality and creativity? Offer telling examples to make the ideas under discussion vivid for the group? And so on.

Weight: 6%

Due date: Monday April 20, 2021. Fill out rubric and hand it in as an appendix to your final paper.

Late assignments will be subject to a 10% per day penalty on the grade they receive.
