Weight: 20% Due Date: March 19, 2021 **Assignment 4: Creative Project** Assessment Method: Portfolio review Description: students will create a proposal for a creative work that uses technology as the primary driver for production. Zoom is a video conferencing program that will allow us to meet at specific times for a "live" video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.
