Course description	An exploration of the applications of technology in performance contexts. Consideration will be given to both simple and advanced technologies, including everyday tools and devices, and the evolution through historical precedents to contemporary and emerging technologies.
Course learning outcomes	By the completion of this course, successful students will be able to: <ol style="list-style-type: none"> 1. Will have an introductory level understanding of technology as a concept and tool; 2. Will be familiar with a range of applications of technology within contemporary performance contexts; 3. Will have achieved an introductory level capacity to integrate technology into their own creative and performing practices. 4. Will have an introductory level of understanding of how and why modes of technology application influence meaning and experience in performance.

Guidelines for Zoom Sessions	<p>Zoom is a video conferencing program that will allow us to meet at specific times for a “live” video conference, so that we can have the opportunity to meet each other virtually and discuss relevant course topics as a learning community.</p> <p>To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor’s permission.</p> <p>The use of video conferencing programs relies on participants to act ethically, honestly and with integrity; and in accordance with the principles of fairness, good faith, and respect (as per the Code of Conduct). When entering Zoom or other video conferencing sessions (such as MS Teams), you play a role in helping create an effective, safe and respectful learning environment.
