Course description	This course will look at the challenges for designers in the preparation of design for contemporary opera production of an opera from the Romantic Period of Opera, <i>Un Ballo in Maschera</i> by Giuseppe Verdi. As well, we will discuss the challenges of contemporary new Canadian plays. As a study we will use the post-dramatic play <i>antigone lives*</i> by Suzanna Fournier. This play has been chosen by WSD as the Scenofest Common Design Project. Students are encouraged to enter the international conversation at Scenofest by resting in the project.

Course learning outcomes	<p>By the completion of this course, successful students will be able to:</p> <ol style="list-style-type: none"> 1. demonstrate a high level of aesthetic competency, visual storytelling, and dramaturgical skill in Costume Design. 2. conduct discourse and analysis of the relationship of scenic and costume design to audience, performer, and other areas of design. 3. articulate in detail and within a critical framework, the process and rigour they have applied to creating their own work – this will take the form of an Artist’s Statement. 4. receive critique and feedback while working and be able to articulately defend artistic choice and ideas orally in classroom setting.

Assessment components	<p>Assignment 1: Textile Morgue Book Assessment Method: Portfolio Description: Each student will create their own catalogue of fabric samples. Weight: 20% Due Date: March 10, 2022</p> <p>Assignment 2: <i>Un Ballo in Maschera</i> Assessment Method: Model, sketches, and drafting. Description: While the focus in this class is primarily on the costume design, students will be asked to create set and costume designs for this theoretical project. Weight: 40% Due Date: Feb. 15, 2022</p> <p>Assignment 3: <i>antigone lives*</i> Assessment Method: Model, sketches, and drafting. Description: Students will be asked to design costumes and set for this project which they are encouraged to enter in the Scenofest Common Design Project. Weight: 40% Due Date: April 15, 2022</p>
Assessment expectations	<ul style="list-style-type: none"> • As each project practices the thinking and organizational processes and the skills needed to complete subsequent projects it is necessary that you participate in and finish all the projects to be successful in this course. • Similarly, all the parts of a project, exercise or sketchbook assignment contribute to the evolution and final realization of the work. Therefore, the Instructor(s) may decide not to accept or grade incomplete projects; all parts of each project must be included in the final submission by the given deadline. • Class exercises, sketchbooks, and projects will be given a letter grade or a grade out of 100 and will be due as noted in the schedule or as specified by the instructor. • Completed projects, exercises, and/or sketchbooks may be accepted after those due dates, but the grade will be reduced by 10% per day late. In other words, work that is graded as A will receive an F after 6 days late.
