Course learning outcomes	<p>-Through in-class projects and assignments, students will demonstrate advanced level of understanding of theory and instrumentation for lighting and projection design for theatre.</p> <p>-Students will examine and critique the work of professional lighting and projection designers and study how that might inform their own process.</p> <p>-Students will interpret a script through lighting and create sketches, draft a light plot and generate the paperwork connected to communicating their desired design.</p> <p>-Through a complex paper project, students will demonstrate expertise in plotting a lighting design.</p>
