Course description	Development of skills in rhythm, intonation and sight-singing. Performance of two- part contrapuntal exercises with diatonic modulation. This course meets for three hours per week during the Fall and Winter terms.
	This course, together with "theory" courses, is designed to help the student musician who intends to make music a career by developing musical skills and an

	understanding of how much is put together. While theory courses focus on
	developing written skills, this course focuses on aural skills and the training of the
	ear. Students will acquire fluency in the use of solfège, sing and notate melodies
	and chord progressions, and develop keyboard harmony skills.
