Assessment expectations	Scores and parts must be prepared and presented at the beginning of the class for which they are due. Musicians, to read the exercise, must be confirmed ahead of time and present in class for the reading. Extra copies of the score must be made available for the instructor at the beginning of the class.
	Criteria That Must Be Met to Pass Assignments must demonstrate sincere and imaginative engagement with the objectives and challenges of the compositional exercise, legible and efficient notation, and participation in its reading or performance.
	Expectations for Writing Writing skills are important to academic study across all disciplines. Consequently, instructors may use their assessment of writing quality as a factor in the evaluation of student work. 	Guidelines for Formatting Assignments: Assigned work can be notated by hand or via a computer notation program. Final projects must include individual parts for each player, as is necessary/appropriate for the piece.
	Missed or Late Assignments: It is expected that all assignments be submitted by the specified deadline. Late assignments will be assessed a penalty of 5% per week. Missed or unsubmitted assignments will receive a 0.
