Course description	<p>The course will present a study of the music of Ludwig van Beethoven through a series of readings and analysis assignments. The course will also include a consideration of Beethoven as a figure across history, dealing with his influence, culturally and historically, from his time to the present.</p> <p>The course will consist of a series of study "modules" involving readings from the text, listening examples, and short analysis assignments. The course will be divided into three teaching units, each of which concludes with a listening test. The answers to the weekly assignments will be submitted by E-mail for grading.</p>
Course learning outcomes	<p>By the completion of this course, successful students will:</p> <ol style="list-style-type: none"> <li>1. Have a good overview knowledge of Beethoven's music.</li> <li>2. Have a knowledge of the basic facts of European history during the of Beethoven.</li> <li>3. Have a working knowledge of the major modern writings that concern the composer.</li> <li>4. Have an understanding the mythic elements that surround Beethoven in classical and popular culture.</li> <li>5. Be able to analyze the music of Beethoven.</li> </ol>
Course schedule	<p>Each Thursday members of the class will be sent an E-mail containing the weekly assignment (questions for the readings or a short analysis assignment). The completed assignments will be due the following Monday (by noon). They will be graded and returned at the time of the following assignment (the following Thursday). Each unit of the course will conclude with a listening test on the items listed in the detailed course syllabus (distributed by E-mail at the beginning of the course).</p> <p>The due dates of the written assignments and listening tests are as follows:  Assignment 1: September 14  Assignment 2: September 21  Assignment 3: September 28</p>
