DESCRIPTION

Addresses theories and practice in learning and teaching Chinese as a second/foreign language. Examines fundamental concepts and critical issues in the field such as learner strategies, motivation and teaching methods.

- 1. Demonstrate knowledge in key issues and concepts in second language teaching and learning
- 2. Describe a wide range of teaching methods and learn to apply them to enhance teaching
- 3. Analyze factors that affect language teaching and learning
- 4. Apply knowledge and skills to deliver research- and theory-informed language teaching
