GERM 357.4 Topics in Film (The Holocaust on Film)

DESCRIPTION What are the moral implications of representing violence and suffering in art? This course approaches this question through an in-depth study of the representation of fascism, anti-Semitism, and the Holocaust in European and American films from the time of the Nazi regime to the present.

OBJECTIVES

- Students gain familiarity with the historical outlines of the Holocaust and current research on the Holocaust.
- Students gain familiarity with the ways in which fascism and Holocaust have been depicted in film from the 1930s to the present.
- Students will be introduced to fundamental moral questions concerning the representation of violence and suffering.

OUTCOMES

- Students will be able to explain key facts as well as dominant questions and controversies surrounding the Holocaust.
- Students will be able to detect—and comment on—common tropes, trends, and problems in the representation of the Holocaust.
- Students will have the conceptual toolset to reflect and comment on the moral implications of the depiction of violence and the representation of victimhood in art.

Technology Requirements:

As per the requirements, students need to have reliable access to technology, as follows:

ASSESSMENT

- Creative assignment: 10%
- Analysis paper (1,000 words): 40%
- Quizzes: 30 % (5 x 6 %)
- Participation during class discussions: 20 %
- <u>Creative assignment (500 words [+/- 10 %]):</u> Students choose <u>one</u> historical or fictional character from one of the films screened in class. They write a fictional letter to the director of the film in which they complain about the representation of that character in the film. Students can choose (but must make explicit) from what perspective they write the letter (for instance, from the perspective of that character, or from that of another character in the film etc.). The letter has to lay out the complaint in clear and precise terms: what aspect of the representation of the character is complained about, and why? In what other manner should the character have been shown instead—and why? To achieve a perfect score, the letter will answer the questions here listed clearly (what character; from whose perspective; which aspect is complained about and why; how else should the character have been shown and why so?), be of the required length, and be in letter form. The creative assignment is due on September 10, 2021 (11:59 pm).
- <u>Analysis paper (1,000 words [+/- 10 %])</u>: Students write a paper in which they analyse Holocaust films by answering one question from a number of provided essay questions (see D2L for details). <u>Essays are due on September 24, 2021 (11:59 pm</u>). The paper will be assessed based on the following criteria:
 - <u>Completion of the task (10/20)</u>: Does the entire paper remain focused on one of the provided questions and does the paper provide a clear answer to all aspects of the chosen question (10)?
 - <u>Construction of argument (13/40)</u>: Does the paper have a clear introduction with a specific thesis statement (5)? Does the paper have a clear and productive conclusion (2)? Does the paper productively discuss counterarguments (3)? Are the transitions between sentences and paragraphs clear (3)?
 - <u>Productive and nuanced work with primary and secondary sources (7/40)</u>: Does the paper provide evidence for its claims by clear references to primary and/or secondary sources (5)? Does the paper include a nuanced discussion of the cited texts and films (2)?
 - <u>Clarity of writing and form (10/40)</u>: Is there a consistent and transparent citation system (2)? Does the essay comply with standard English grammar and spelling (2)? Is the paper

stylistically appropriate (2)? Does the paper have a descriptive and well-suited title (2)? Is the paper correctly formatted (a Word document, using 12 point Times New Roman and double-spacing) (2).

Please note: The grade will be lowered by 2 points for every 100 words that the paper deviates from the required word count.

- <u>Quizzes</u>: The quizzes consist of multiple-choice questions and will test knowledge and understanding of the lectures, films, and required readings of the respective day. Students complete quizzes on D2L. Quizzes have to be completed by <u>September 10, 2021 (11:59pm</u>).
- Participation during class discussions: On each day, the class will come together for a discussion of the films. During these discussions, students will be presented with two questions to which they have to post brief answers. Answers can be posted during discussions sessions, and they must be posted by the end of the day on which they are assigned. Answers will be graded based on completion only (a complete answer directly and clearly responds to the question in at least two grammatically complete sentences). Students are encouraged to discuss their answers among them, but each student must formulate and submit their own answer.
- All written assignments must be UPLOADED TO D2L. Please use WORD DOCUMENTS for all written assignments, and please include your full name in the name of the file.
- For each 24 hours that an assignment is late, one point will be deducted. Please reach out to the instructor prior to the due date to arrange accommodations if appropriate.
- Any assignment that is not submitted will be graded at zero points.
