DESCRIPTION

This German language class focuses on the improvement of reading and writing skills through the critical and creative engagement with the fairy tales collected by Jacob and Wilhelm Grimm. This course places great emphasis on peer learning.

OBJECTIVES

- Students will improve their German reading and writing skills.
- Students will strengthen their abilities to improve their work in collaboration with peers.
- Students will improve their ability to reflect on the principles guiding their work and to make them transparent to their audience.
- Students will critically engage the fairy tales collected by Jacob and Wilhelm Grimm.

OUTCOMES

- Students will be able to extract important information from complex German texts.
- Students will be able to summarize a text, to describe its formal and stylistic features, and to comment on it in German in written form.
- When writing an essay, students will be able to tie their arguments to written sources in a transparent and convincing manner.
- When translating a text, students will know how to formulate principles guiding their work.
- Students will be able to communicate productive feedback on written work presented by their peers.
- Students will be able to recognize and comment on typical formal and stylistic features of the fairy tales collected by Jacob and Wilhelm Grimm.

Technology Requirements:

As per the requirements, students need to have reliable access to technology, as follows:

ASSESSMENT

Homework: 14 % (14 short assignments worth 1 % each)

Essays: 36 % (4 essays worth 9 % each)

Creative assignment: 6 %

Participation: 20 %

Quizzes 24 % (3 quizzes worth 8 % each)

Homework: There are 14 homework assignments. Homework assesses students' understanding of the assigned readings. Homework has to be submitted on D2L prior to the class meeting for which it was assigned, and it should be ready at hand during class meetings. Homework will be graded based on completion.

Essays: Students write 4 short essays (500 words each, +/- 10%). Essays will be graded based on completion of the task (3% per essay), structure (introduction and conclusion, clear transitions) (2% per essay), vocabulary (appropriate register, variety, and correct usage) (2% per essay), and grammatical structures (variety and correctness) (2% per essay).

Creative writing (500 words, +/- 10%): Students write one fairy tale of their own invention. In its content and/or narrative structure, the fairy tale has to be based on the fairy tales collected by Jacob and Wilhelm Grimm. The creative assignment will be assessed based on the following criteria: completion of the task (2%), vocabulary (correct usage) (2%), grammatical structures (correctness) (2%).

Quizzes: Three quizzes test students' grasp of grammar introduced in class. Quizzes will be available on D2L for at least 24 hours prior to the due date (see detailed class schedule on D2L).

Participation: Students are asked to participate in class discussions by sharing results of their homework and/or providing additional comments and questions. To receive a perfect grade, students must make 20 substantial contributions in German over the course of the semester. Students may choose to supplement their contributions with short reflective statements (c. 100-200 words each, in German) about individual class meetings. Each of these statements will be worth up to 3 points (to achieve a perfect score, the writing must be clear, and the statement must demonstrate familiarity with the content of the lecture, assigned reading, or class discussion). These statements have to be emailed to the instructor no later than 48 hours after the meeting on which they comment.

PLEASE NOTE:

- All writing assignments (except for the reflective statements contributing to the participation component) have to be uploaded D2L. Please use WORD DOCUMENTS for all written assignments, and please include your full name in the name of the file.
- For each 24 hours an assignment is late, one point will be deducted. Please reach out to the instructor prior to the due date to arrange accommodations if appropriate.
 Any assignment that is not submitted will be graded at zero points.

INTEGRITY AND CONDUCT

Academic misconduct

- 1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

- 2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers
- 3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
- 4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
