DESCRIPTION

How do we make sense of words, phrases and sentences in language? How is it possible that the meaning of a sentence rarely equals the sum of the words included in it? Does natural language have formal logical components? What do we know about how language meaning might interact with other cognitive systems, or paralinguistic and extralinguistic aspects of our environment? This course introduces us to the study of meaning in natural language.

OBJECTIVES

We will explore theoretical issues and approaches regarding natural language semantics and cover the major extant theories of semantics including componential theory, formal semantics, and cognitive semantics. In addition we will try to address the semantics/pragmatics interface. When possible, we will try to connect these with experimental evidence coming from the field of psycholinguistics including language acquisition and processing.

OUTCOMES

Students will acquire a good understanding of basic terminology and theoretical concepts and approaches in semantics. Through practice with appropriate problem sets and exercises, they will be able to apply this knowledge to basic questions about meaning in natural language.

All assessments contribute to successfully pass the course. Assessment is going to take place online through D2L and is going to be asynchronous. That is, the assessment materials (including exams) will be made available to the students ahead of time and the students will have deadlines by which to submit their responses. Students will be able to work on those on their own time (i.e. over several days or a week) and will not have timed assessments or examinations. Allowed aids include the textbook, lecture slides, and course notes. Due dates for the Midterm and Final exam will be finalized after consultation with the class but are tentatively set as seen above.

Academic misconduct

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to

establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
