DESCRIPTION

This introduction to the study of speech language pathology (SLP) provides students with an overview of the field including major facts underlying normal and disordered communication, various conditions dealt with by the profession, and a discussion of broader professional issues.

Students should read the relevant textbook material prior to each lecture. Class time will be used for instructors to provide deeper explanation, and to share examples and practical applications. Students are expected to engage with their peers during classroom activities, and participate in classroom discussions. There are a number of written assignments spread throughout the term.

OBJECTIVES

On course completion, the student will be able to

- identify key points related to both normal and disordered communication
- understand the influences of various conditions on speech, language and swallowing ability
- define key terminology associated with SLP
- discuss professional issues of current concern to SLP
- appreciate the social/emotional/vocational implications that communication disorders can have on individuals and their families
- make an informed decision with respect to pursuing further education in SLP.

* Final assessment will consist of a written assignment that covers material from the whole course. Each student must complete the assignment independently; failure to do so constitutes academic misconduct. The final assessment assignment will be **available in Dropbox Friday April 17 at 2:00pm**, and must be completed and **submitted via Dropbox by Friday April 24 at 2:00pm**. There will be no deferrals granted for the final assessment assignment. There will be a deduction of 50% if final assessment assignment is submitted up to 24 hours late. There will be a mark of zero if final assessment assignment is not submitted, or submitted more than 24 hours late.

ACADEMIC MISCONDUCT

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
