DESCRIPTION

This course continues the introduction to phonetic study that began in Linguistics 341.

OBJECTIVES

In this course, students will hone their acoustic analysis skills through a small, phonetic field study on an unfamiliar language, learn the TOBI system for the transcription of intonation in English, develop laboratory skills for the acquisition of experimental phonetic data, acquire in-depth knowledge of the mechanisms involved in the production, perception and acoustics of speech, and become familiar with the primary theories in the field of phonetics.

OUTCOMES

Upon conclusion of the course, students should be prepared to conduct an honors-level research project in phonetics.

ASSESSMENT

The course grade will be based on your performance on homework exercises, a semester-long course project, a midterm exam and a final exam.

Homework will consist primarily of laboratory exercises that are designed to improve your skills in collecting and working with phonetic data. We will go over, in detail, the requisite tools and skills necessary to complete these exercises during the course of the semester. The due date and time for each homework will be provided when that homework is posted online during the semester; homeworks will generally be posted about a week before they are due. Students will submit their completed homework assignments in digital form, online, via D2L. If you are ill or cannot meet a homework deadline due to a personal emergency, please let me know as soon as possible.

Course Project. Your primary responsibility in this course will be the execution of a small, phonetic field study involving a native speaker of an unfamiliar language. For this project, you will collect acoustic and articulatory data from your speaker and then analyze it using the tools and principles we have discussed in class in order to better understand the phonetic structure of your consultant's language. You will write up your findings on your consultant's language in a series of short lab reports throughout the semester. More details on this project will be provided in an additional handout that we will go through together on the first day of class. Note: I am happy to entertain alternative ideas for course projects. Please come talk to me as soon as possible if you have an idea for another project that you would like to work on over the course of the semester.

Exams. The mid-term exam will exclusively focus on material covered in the first half of the term, and the final exam will primarily focus on material covered in the second half of the term. Both exams will be administered online and will include both timed and "untimed" components. The "untimed" components of each exam will take place within a 24-hour window and will require you to complete tasks that may involve technical challenges that can take some time to solve (creating text grids, drawing diagrams, scanning answer write-ups, etc.). The timed portions of the exams will be run entirely online, via a form that you can fill out in a web browser. The timed portion of the mid-term will be 75 minutes long, and the timed portion of the final exam will be two hours long. Students who encounter technical difficulties during an exam should contact me (at swinters@ucalgary.ca) as soon as possible, so that I can adjust the exam timing requirements in your situation accordingly. The specific details of how these exams will be administered will be provided as we make our way through the semester. If you are ill or cannot take an exam due to a personal emergency during the scheduled time for an exam, please let me know as soon as possible.
