DESCRIPCIÓN

En este curso se hará un análisis del *Quijote* de Cervantes, teniendo en cuenta el contexto sociocultural e histórico, la historia literaria y la teoría de la novela.

Objetivos: fomentar la lectura del *Quijote*; presentar el contexto histórico y literario de la novela cervantina; mejorar el análisis literario y la capacidad para la investigación; presentar ideas centrales de la teoría de la novela; profundizar el conocimiento de la teoría literaria; mejorar la expresión escrita y oral en el español además de la lectura.

Prerequisitos: permiso del departamento.

COURSE NOTES

El ensayo final será un trabajo de investigación sobre un tema relacionado con el *Quijote* y se escribirá conforme a las normas bibliográficas vigentes. Ya que se requiere que se haga investigación para el trabajo final, el/la estudiante consultará fuentes secundarias de índole académica (un mínimo de 10), las citará correctamente y evaluará su contenido a la vez que formulará su propia lectura de la obra literaria en cuestión. En todas las actividades escritas, los estudiantes recibirán dos notas de igual valor: una que corresponderá al análisis, la argumentación y el pensamiento, y otra que corresponderá al uso adecuado de la gramática y del vocabulario. En las ponencias orales se evaluarán el contenido además del buen dominio de la gramática y la expresión oral.

Será necesario completar todos los trabajos del curso para aprobarlo.

Se aceptarán trabajos después de la fecha límite en el caso de presentar una nota médica. Asimismo se permitirá escribir un examen perdido en el caso de presentar una nota de un médico.

No se acepta la entrega de los trabajos a través de correo electrónico.

ACADEMIC MISCONDUCT

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
