Together with LWSO 413, this course replaces LWSO 412.

Course Description

This course starts where LWSO 413 left off, starting with John Rawls and more recent scholars working in the liberal tradition. We examine the implications of these theories for contemporary socio-legal problems around such issues as privacy, campaign finance, and the relationships among liberty, equality and property.

Objectives of the Course

Students are to gain a detailed understanding of liberalism and its workings in Canada, with some comparisons to other jurisdictions. They will enhance their analytical skills and craft thoughtful, coherent, creative arguments about liberalism and its real-world manifestations.

Textbooks and Readings:

Edited versions of cases will be available on Blackboard, as will links to other materials. The following book will be used:

- John Rawls, *Justice as Fairness: A Restatement*, ed. Erin Kelly (Belknap Press, 2001)
- Martha C. Nussbaum, *Frontiers of Justice: Disability, Nationality, Species Membership* (Cambridge, MA: Belknap Press, 2006)

Assignments and Evaluation

- Midterm: Rawls (30%/25%)* – Tues. Feb. 6 – closed book
- Nussbaum assignment (30%) – Thurs. Mar. 13
- Final exam (40%/45%)* – in the final exam period – closed book

* NOTE: The midterm and final exam will be weighted so as to give students the benefit of their higher mark. If your higher mark is on the midterm, the midterm will count for 30% and the final for 40%. If your higher mark is on the final, the midterm will count for 25% and the final for 45%.

The grade for the course and whether or not a student passes it will be based on the student's accumulated score and will not depend on passing any particular component of the course.

It is the student's responsibility to keep a copy of each submitted assignment.

Note: Please hand in your essays directly to your instructor if possible. If it is not possible to do so, please submit your work electronically, either using the Blackboard dropbox or through email. It is my practice to acknowledge receipt promptly of all work submitted electronically – if you do not receive such an acknowledgement, ask me for it.
