Course Description

Since this course is the integrative seminar for the Law and Society program, the overall goal is to permit students to bring to bear the whole range of their experience and knowledge in the Law and Society degree. Students will read critically to analyze social issues and design a research project that will accomplish these objectives.

Course Objectives/Learning Outcomes

By the end of the course students should be able to critically evaluate legal philosophical and theoretical texts and a variety of other materials as well as understand the way in which the law, politics, and society influence each other and how the law in Canada and other liberal democracies is made and reformed over time.

This section of LWSO 591 will address specific questions about the history and future of socialism in modern society. We will evaluate and discuss alternatives to capitalism and liberalism and discuss the question, “why not socialism?”

Course Format

The course will be run asynchronously. There are no required scheduled meetings with the instructor. Students may check in through scheduled Zoom meetings once per week, but these are not required. Students can also interact with the Instructor or T.A. through the D2L message boards and chats to access assistance and guidance with the readings and assignments.

Students will work together towards the completion of three writing assignments. This can take place through the D2L message boards, chats, and Zoom meetings within your assigned peer groups.

Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a re-assessed grade may be raised, lowered, or remain the same.

Handing in Papers, Assignments

1. The main Sociology Department office does not deal with any course-related matters. Please speak directly to your instructor.
