## **Course Description**

The course offers foundational insights into what the discipline of sociology is all about. While the course is seminal, it is a vital window for having a good grasp of the issues that sociologists interrogate. From micro level interactions to macro levels of relationships, social structures as well as their functions constantly reflect the complexities of human societies. While the areas covered by sociological enquires are vast, sociological concerns can be summarized into a triad of social inequality, social institutions and social change. Interactions in all societies revolve around these tripartite foci. In this course, learners will have the opportunity to not only gain theoretical knowledge but also contribute to teaching and

learning processes by way of engaging in class conversations, online discussions, as well as making sense of their lived experiences through reflections.

## **Course Objectives/Learning Outcomes**

This course prepares learners to smoothly embed into sociological thinking. As such, at the end of the course, learners are expected to be able to:

- construct a definition of sociology using relevant concepts.
- distinguish between common sense and sociological explanations of social phenomena
- identify various theories sociologists deploy in their enquiries
- apply sociological imagination to explore how their behaviours affect people around them and how they are also affected by those of others
- interrogate social inequality in a Canadian context using historical and global lenses
- critically examine and analyze how society changes and how these changes impact individuals.
- engage in sociological discussions both in theory and practice.

## **Methods of Assessment and Grading Weights**

Learners will be examined on their knowledge in the course by a variety of assessment methods. These are explained below.

1. Introductory Reflection. Learners will begin the course by completing an introductory reflection where they will interrogate and examine their assumptions, notions, and biases about the social world. The reflection will be a maximum of 200 words and will be marked on a pass/fail basis.

- 2. Midterm Exams. Students will complete two midterm exams over the course of the semester, which will comprise of multiple choice and True or False questions. These exams will be non-cumulative and will test students' understanding of the course material to date. Each of these exams will last for 60 minutes. There will be no deferral or extension provided to these exams unless this has been communicated at least 48 hours prior to with the instructor. If a deferred or extension is provided to complete the exam, the instructor will set a date/location/time that is convenient for them and will communicate that to students. Please note that the format of deferred exams will be solely long essay-based.
- **3. End-of-Class Reflection**. Learners will be asked to reflect on what they have learned in the course by way of reflection where they will use the knowledge gain in the course to make sense of their lived experiences. The reflection will be a maximum of 500 words and will attract 10% of the total marks obtainable in the course.
- 4. **Online Discussions**. To build a strong learning community, students will be required to engage in D2L discussion board posts on a weekly basis, where they will be required to respond to a prompt. This will attract 10% of the final grade. There will be 5 discussion posts throughout the course and each post will be worth 2% of the final grade.
- 5. **Final Exam**. The final examination is registrar scheduled. Please note that all deferred final exams are scheduled by the Registrar's office and may consist exclusively of long-answer questions.

#### **Passing Grades**

Learners are required to complete ALL course requirements to successfully pass the course, but you do not need to pass each course component to earn a passing grade in the class.

#### Missed or Late Coursework

While I am aware that different life's circumstances can prevent students from submitting assignments and completing other required tasks in this course, it is important to ensure that the students make effort to communicate their need/s for exemption or extension before due dates of such tasks. As such, late assignments will be penalized 5% per day, including weekends and holidays without prior instructor's approval. All assignments must be submitted to the Dropbox on D2L.

Similarly, missed examinations/tests cannot be made up without the approval of the instructor.

Students who missed a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It is at the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. For instance, multiple choice question or quiz could become a short answer or an essay test. Once approved by the instructor, a makeup test/exam must be written within two weeks of the missed test/exam on a day/time scheduled by the instructor.
