# **Course Description**

This course offers a critical, empirically-informed look at research processes including problem definition, data collection and analyses; quantitative and qualitative strategies will be discussed in order to properly understand the social research methods that inform the discipline of sociology.

# Course Objectives/Learning Outcomes

This course will provide the students with the opportunity to:

- 1. Examine diverse social research methods.
- 2. Grasp the complex relationships between data collection and sociological analysis.

- 3. Understand the quantitative and qualitative strategies employed by social scientist to approach social reality.
- 4. Explore the central elements of sociological research design.
- 5. Develop an understanding of the ethical issues associated with social research.

#### **Course Format**

This course will have a Hybrid format. This means that it will require both synchronous and asynchronous involvement by students. In terms of synchronous involvement, we will have one-hour and fifteen minutes lecture sessions on Mondays and Wednesdays from 10:30 to 11:45 am. These lectures will be recorded for those that cannot access them in real time. Lectures notes will be also posted on D2L. We will also have labs on Mondays and Wednesdays from 13:00 to 14:00 where students will be able to practice different social research methods. In terms of asynchronous involvement, the course will include online discussions, assignments and readings to be completed by students outside of lecture time. The due dates for these activities will be indicated over lecture and in D2L.

# **Grade Reappraisal**

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. It should be noted that a reassessed grade may be raised, lowered, or remain the same.
