### **Introduction**

Why do members of society use force and fraud? That is, why do people not simply use socially acceptable means of attaining their wants and needs? This course will introduce students to salient theories constructed in the sociology of deviance and social control. What is deviance and who has the ability to define it? Does this definition change over time? Do we try to control seemingly harmless types of deviance? From our readings and congenial class discussions, we will explore these issues by considering how various sociological theories approach them. As I expect students to be active producers rather than passive consumers of ideas, classes will involve a measure of informal discussion rather than just formal lecturing. Students are warned that, at times, this class deals with graphic and violent themes in both lectures and videos.

They are *intended* only to provide a brief outline of what will be covered in lectures and it is expected that you will need to take additional notes.

### **Evaluation**

**The following policies were constructed by the Department of Sociology and apply to this course.**

### **Exam Policies**

You must provide advanced notice to the instructor if you are unable to take an exam. All requests for deferral of an examination due to health reasons must be accompanied by written documentation as outlined in the University Calendar and should be obtained while the student has the physical or emotional problem rather than after recovery. Deferred exams may be allowed in the following circumstances: illness, domestic affliction or religious conviction. If you have missed an exam for a legitimate reason, you must arrange to write a “make up” exam as close to the original exam as possible. The date and location will be at the convenience of the Sociology Department. Travel arrangements and misreading of the syllabus are not valid reasons for requesting a deferred exam. Deferred exams will not be granted if it is determined that just cause is not shown by the student.

### **Ethics Research**

Students are advised that any research with human subjects--including any interviewing (even with friends and family), opinion polling, or unobtrusive observation-- must have the approval of the Departmental Ethics Committee. In completing course requirements, students must not undertake any human subjects research without discussing their plans with the instructor, to determine if ethics approval is required.

### **Academic Misconduct**

Cheating is regarded as a serious academic offense. Students are advised to consult the University Calendar, which presents a Statement of Intellectual Honesty and definitions and penalties associated with cheating, plagiarism, and other academic misconduct.

**The Freedom of Information and Protection of Privacy (FOIP)** legislation disallows the practice of having students retrieve assignments from a public place, e.g., outside an instructor’s office or the Department main office. Term assignments must be returned to students individually, during class, or during the instructor’s office hours; if a student is unable to pick up her/his assignment s/he may provide the instructor with a stamped, self-addressed envelope to be used for the return of the assignment.
