Course Description

This course introduces students to the sociological study of deviance, conformity and social control. Students will be exposed to the various was in which society regulates behaviour and the processes by which individuals and groups are socially constructed as deviant. They will also be introduced to the various theoretical explanations of why some individuals are considered deviant and others are not. Students will consider consequences of social definitions, and factors that influence conformity and deviance. We will look at various forms of deviance, and discuss the labels and effects of those labels on social interactions. We will also consider how deviant labels are used as a form of social control.

Course Objectives/Learning Outcomes

Upon completion of this course, student will be expected to have knowledge of the following:

- 1. How deviance and conformity are socially constructed and reinforced by social control in society.
- 2. The challenges of measuring deviance and crime in society.
- 3. The positivist, interpretive and critical theories of deviance, conformity and social control.
- 4. The various forms of deviance that are identified in society.
- 5. The relationship between power, deviance, conformity and social control.

Methods of Assessment and Grading Weights

1. Midterm exam #1: Jan 31 online via D2L (worth 25% of your final grade)

Midterm # 1 will be available on D2L at the beginning of class on January 31, 2022 and will be available for 24 hours. When you access the assessment, you will have 75 minutes to complete and submit it. This exam will consist of multiple choice and true/false questions. This midterm is open book, you can only access your class notes or material on D2L.

If you experience an issue that affects your ability to complete the exam, which can include (but is not limited to) issues with technology, caregiving responsibilities, or distractions within your test-taking environment, you will need to contact your instructor as soon as possible to arrange an alternate or (in the case of technical issues) extended time to write the assessment.

2. Midterm #2: March 9

Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis

for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss their own work and rationale. It should be noted that a reassessed grade may be raised, lowered, or remain the same.

Handing in Papers, Assignments
