Course Description

2022 left us with considerable political and criminal conflict. Many cities had weekly protests regarding vaccine policies and masking requirements, while many Canadians found the protests disruptive. Ottawa experienced a protest that effectively shut down the core for over two weeks. People living in the area complained that protesters in trucks kept them awake all night because horns were used continuously. Many felt intimidated by protestors. Meanwhile, the Royal Canadian Mounted Police (RCMP) managed to seize weapons and ammunition at a protest in Coutts, Alberta. Four of those protestors were arrested and charged with conspiracy to murder RCMP officers. Why are some law breakers arrested and charged, while others are not? Why are some people granted bail while others are not? How does the Canadian justice system handle such cases? Ultimately, is the Canadian justice fair and effective at handling crime?

Course Objectives/Learning Outcomes

Students in Introduction to Criminal Justice should concentrate on how to:

1. Identify the main components of the Canadian criminal justice system.

2. Outline the general process that suspects go through when they are accused of perpetrating crime.
3. Identify and explain control philosophies.
4. Memorize important notable crime rates and trends.
5. Explain the challenges presented by policing society, dealing with the courts, and sanctioning the convicted.
6. Identify and assess viable alternatives to prison.

Required Textbooks, Readings, Materials, Electronic Resources

The following textbook will be used in this course and is available in the Bookstore. Oxford University Press also has an electronic version available at a lower price for a 6-month term.

Ruddell, R. (2020). *Exploring criminal justice in Canada (2nd ed.)*. Don Mills: Oxford Publishing. Students will be expected to carefully consider each assigned reading before lectures. There will also be external links to videos from time to time on D2L.
