### Course Description

This class will introduce students to the structure and operation of the Canadian criminal justice system. While it may be assumed that crimes should be sanctioned according to the letter of the law, the reality is that the law is in constant flux. As social norms change and technological innovation occurs, the criminal justice system needs to respond. We will examine how the various stages of the system function. This will include an examination of how crime is defined, measured, and dealt with by the police, the courts, and the correctional system. Upon successful completion of this course, students will be able to identify the values of the Canadian criminal justice system, illustrate how informal justice manifests itself, and critically assess crime stories in the mass media.

I expect students to be active producers rather than passive consumers of ideas. As such, classes will involve traditional formal lectures, but they will also include a considerable amount of student activity and participation. This means that there will be many short class exercises and discussion (among students and with the instructor). I also encourage students to draw upon their own personal experiences as valuable sources of information. **Students are warned that, at times, this class deals with graphic and violent themes in both lectures and videos.**

### Course Objectives/Learning Outcomes

Students in Introduction to Criminal Justice should concentrate on how to:

1. Identify the main components of the Canadian criminal justice system.
2. Outline the general process that suspects go through when they are accused of perpetrating crime.
3. Identify and explain the control philosophies.
4. Memorize important and notable crime rates and trends.
5. Explain the challenges presented by policing society, dealing with the courts, and sanctioning the convicted.
6. Identify and assess viable alternatives to prisons and fines.

### Required Textbooks, Readings, Materials, Electronic Resources

The following texts are required reading in this course:

Griffiths, C. T. (2019) *Canadian criminal justice: A primer*. (6<sup>th</sup> ed.). Toronto: Nelson.

Other than the text identified above, there are no other materials to be purchased or used in this class.

Students will be asked to consider news items on D2L from time to time. No other electronic resources will be used.

### Methods of Assessment and Grading Weights

There are several opportunities for students to capture their grades. Exam dates are listed in the “Schedule of readings”. Students will have two mid-term examinations in true-false and multiple choice format. The mid-term examinations are both worth 30%. Given departmental resources, there will be no deferred mid-term examinations. The percentage of the missed mid-term will be equally divided to the other examinations (i.e. 50/50). This policy will remain in effect during the closure of the university.

### Final Exam Information

The final examination is worth 40% and will also be in true-false and multiple choice format. The final examination is not cumulative. It will be held online via D2L. Further instructions will be disseminated via a D2L news item and electronic mail. The date of the final examination will take place as per the current final examination schedule on your student centre.

## Passing Grades

In order to pass the course, students must obtain 50% or more overall as per the grading scale.

## Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a re-assessed grade may be raised, lowered, or remain the same.

## Inclusivity

We live in a diverse social world. Although diversity is often considered visible, that is often not the case. We frequently do not know what challenges others face because all aspects of their lives are simply not visible.
