Course Description

This course is a survey of the sociological study of inequality and social stratification. It is designed to introduce the student to major concepts, assumptions, research findings, and theoretical explanations on the topic. Special focus will be given to structural inequalities and their manifestations in Canadian society including; class, race, gender, age, sexual orientation, and Indigeneity.

Course Objectives/Learning Outcomes

- 1. To familiarize students with the sociological concept of social stratification and inequality.
- 2. To familiarize students with various historical and contemporary theories of social stratification and explanations for inequality.
- 3. To identify factors and characteristics responsible for social stratification in society.
- 4. To explore manifestations of inequality in Canadian society, their impact on lived experiences, and to propose possible solutions.
- 5. To discuss and remain aware of various examples of social stratification and inequality in our contemporary society as they may arise from time to time during the term.

Course Format

Classes are synchronous and will combine several formats: text readings, guest lectures, videos, and inclass assignments. I will cover some of the assigned readings but I will also lecture from additional materials. Therefore, you are responsible for any assigned readings and other materials posted on D2L. I will hold office hours (via Zoom) from 9:00 AM until 11:00 AM each Tuesday morning. Please feel free to contact me if you are having any issues with the course. Students should check D2L every Tuesday morning to receive their weekly course materials.

Methods of Assessment and Grading Weights

Examinations 100%

There will be two mid-term examinations and one final examination. The examinations will cover lectures, guest lectures, videos, class discussions, and assigned reading materials scheduled up to the exam. This means that students will also be responsible for readings and topics not covered in class.

The examinations will be 75-minutes and will have multiple choice and true/false questions. The <u>midterm</u> exams will be accessible on D2L for 24 hours beginning at 12:30 on the dates listed below. When you access the exam on D2L, you will have 2 hours to complete it.

The exams are non-cumulative. This means the exams will cover only materials from the last exam. Please see the course schedule to determine which materials will be covered on each exam. Examination dates <u>and times</u> are strictly enforced.

Passing Grades

Receiving a grade in all components of this evaluation -- including in-class activities and reflective journal entries -- is mandatory to obtain a passing grade in this course. The minimum passing grade for this course is 50% or a "D" grade.

Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a reassessed grade may be raised, lowered, or remain the same.

Handing in Papers, Assignments

- 1. The main Sociology Department office does not deal with any course-related matters. Please speak directly to your instructor.
- 2. Protection of Privacy: The Freedom of Information and Protection of Privacy (FOIPP) legislation does not allow students to retrieve any course material from public places. Anything that requires handing back will be returned directly during class or office hours. *Media recording for lesson capture
