## **Course Description**

This course is about the social organization of criminal justice in Canada. While Sociology 327 introduced students to the basic operations of the Canadian criminal justice system, this course explores shortcomings of the justice system. That is, the course considers how it does not live up to its stated objectives. We will consider why many citizens believe that crime is rampant and the system too lenient on criminals. As well, we will explore how class ideology generates inequities in terms of policing, sentencing, and incarceration. Lastly, we will look at prospects for change in Canadian criminal justice. Upon successful completion of this course, students should be able to identify problems in the operation of the criminal justice system and think critically about positive social change.

#### **Course Objectives/Learning Outcomes**

To identify and explain the philosophical principles of the Canadian justice system.

To identify how social inequities influence policing, sentencing, and sanctioning.

To explain how a lack of community affects crime rates.

To apply pyrrhic defeat theory and broken windows theory to instances of crime in Canada.

To evaluate the arguments posed by Reiman/Leighton and Wilson, and make suggestions for improving social justice in Canada.

## Required Textbooks, Readings, Materials, Electronic Resources

The final examination will be in short answer and long answer format and is cumulative.
