Course Description:

This seminar will focus on the understanding and application of Aboriginal Health in Canada. In this seminar-based course students will critically examine key determinants of Indigenous health, including basic concepts, theories, methods and ethical issues outlined in the contemporary Indigenous health literature. This course is based on an overview of historical and contemporary literature. The student will examine gaps in the health and social status of Indigenous and non-Indigenous peoples, and identify processes leading to these gaps.

Course Format: Individual reading course.

Course Objectives:

Students will be challenged to:

- 1. To provide a factual basis on which to assess issues and situations regarding the handling of Aboriginal health issues in Canada.
- 2. To identify and analyze the key components of Aboriginal health in Canada.
- 3. Identify theoretical frameworks for understanding how health and social inequalities are created.
- 4. Describe the key methods used to measure health and social phenomena among Indigenous peoples.
- 5. Think critically about how theoretical and/ or methodological approaches can be used to improve the health and social conditions of Indigenous people.
- 6. To become aware of the historical and contemporary policies, programs, problems, practices, issues and ironies inherent in the service of health to Canada's indigenous peoples.

Evaluation:

The assignments will be worth 100 points. Feel free to consult me if you have any questions or concerns regarding grades. Final grades will be assigned according to the University of Calgary's 4-point grading system based on the following percentage distributions:

The A+ grade became an official grade at the University of Calgary in fall 2002. The A+ grade is described as an honorific grade having the same grade point value as an A grade (4.0). It will be used to indicate outstanding performance in a subject area but not have a higher grade point average.

There are two components to your evaluation. They are:

i) Proposal 20%

Students must jointly submit a one-page research proposal that details the topic you plan to research and how you plan to complete the project. The proposal is due March 1.

ii) Paper 80%

You can make minor revisions to your class presentation and develop it into a research paper (25 page, fully-cited, typewritten, and double-spaced, 12-point Times New Roman font, numbered, with 1-inch margins, and stapled). Your paper is due on April 16.

Freedom of Information and Protection of Privacy (FOIP):

"The Freedom of Information and Protection of Privacy (FOIP) legislation disallows the practice of having student's retrieve assignments from a public place, e.g., outside instructor's office, the department office, etc. Term assignments must be returned to students individually, during class or during the instructor's office hours; if a student is unable to pick up their assignment from the instructor, they may provide the instructor with a stamped, self-addressed envelope to be used for the return of the assignment".

Research Ethics: Students are advised that any research with human subjects must have the approval of the Department of Sociology's Ethics Committee. Students MUST NOT undertake research projects with human subjects without discussing the topic with me and getting my approval to proceed.
