DETAILED COURSE DESCRIPTION

Welcome to Nursing 203.

Nursing 203, Foundations for Nursing Practice, is a classroom lab course designed to assist you in the development of relational communication skills and psychomotor skills that are foundational to the practice of nursing. Using experiential learning opportunities in the Clinical Simulation Learning Center as well as in the community, you will focus on practicing selected clinical skills within the context of a professional relationship. You will have the opportunity to apply what you have learned in this course in subsequent clinical courses.

COURSE OBJECTIVES

Students in Nursing 203 will be provided with opportunities to:

- Develop skills in relational communication practices
- Demonstrate competence in selected foundational nursing practices
- Apply theoretical content to foundational nursing practices and relational practices
- Apply skills of inquiry and critical thinking to simulated and actual nurse-client situations
- Demonstrate professional behaviors and communication in the learning environment and in the community

Learning Context

Learning resources for N203 include your life experiences, assigned readings, videotaping and video critique, group discussions, supervised lab practice, and a visit to an individual in the community. Each activity in the teaching-learning dynamic is an opportunity to gain insight into being a client, a nurse and to begin the development of the identity of a professional nurse.

To support your learning and to facilitate communication with your peers, lab instructor and course coordinator, a web site has been established for N203 in the Blackboard environment. Under the Lab resources tab, you will find schedules, evaluation tools, lab guides, and other materials to support your learning. There is a tutorial for Blackboard at http://elearn.ucalgary.ca/ if you are unfamiliar with this learning environment. It is an expectation of the course that all students monitor the N203 Blackboard site regularly for announcements related to the course.

Evaluation Expectations

Six multiple choice will be posted on Blackboard. Each quiz relates to the required activities for a particular lab. All quizzes must be completed prior to the last class date. It is recommended that they be completed shortly after the associated lab session to promote integration of concepts.

2. Developing Professionalism (Professional Conduct and Communication)

As a registered nurse your professional practice and conduct will be guided by a set of Practice Standards. These standards, which include a code of ethics, represent criteria against which the practice of all nurses is measured. Likewise, within the scholarly community of the Faculty of Nursing, learning partnerships are established between faculty and students, students and patients, students and students etc. that also require the practice of personal/academic integrity. Please refer to the University of Calgary Calendar 2008-2009, Academic Regulations, pp. 23-58.

Development of professional behaviour in this course will be guided by the five 'P's of professionalism: Presence, Punctuality, Preparation, Participation, and Professional demeanour. (Roach,1992) Communicating with others in a professional manner is also an essential skill required of you in your developing role as a nurse. The following guidelines may be discussed on an ongoing basis in this course and will be used to evaluate 1) your **professional conduct** and 2) **communication.** It is recommended you review the five P's and reflect upon your work with your peers and your instructor. The list below provides a basis for determining your progress in this component of the course. This is a pass/fail evaluation activity and failure to meet any of the individual, or grouped, expectations of this component of the course will place you at risk for failure in this course.

4. Skills Testing

Individual appointments will be set up by your Lab Instructor to test specific lab skills. The current evaluation checklists are posted on the Blackboard for your review and consideration.

5. Math for Medication Administration: eDose submissions

In preparation for the safe administration of medications to clients across the lifespan and in various contexts, you will complete a series of math learning activities and tests throughout your program of study. The importance of accuracy and consistency in carrying out mathematical calculations cannot be overstated. You are required to purchase eDose

which is an independent electronic learning system designed to teach nurses to calculate medication dosages. It will be used in several clinical courses throughout the undergraduate program, beginning in N203. The course coordinator will monitor progress and completion of the assigned modules, which must be completed at the intervals noted in the schedule at a glance to meet expectations in this course. Basic (non-programmable) calculators may be used in the completion of eDose modules and tests. There are additional math texts and learning modules available in the Learning Center.

The last date for withdrawal from this course without penalty is October 7, 2009.

CLINICAL ABSENCES

Within the Nursing Practice Standards established by CARNA (2005) it states that a nurse must ensure their 'fitness to practice' (pg. 5). This means that the nursing student must be able to perform essential functions of the nursing role expected for the lab or clinical practice that they have been assigned to without any mental or physical disabilities/illnesses. Therefore, it is your professional accountability to maintain your state of health and recognize the impact of ill- health may have on patients and colleagues.

To fulfill course requirements, attendance at all scheduled lab and/or clinical practice is required. If you are ill or experience an unforeseen circumstance, you must inform your Clinical Instructor and Course Coordinator as soon as possible. If you miss one or more lab/clinical days due to illness or unforeseen circumstance, you may be at risk for not successfully completing the course. You may be asked to withdraw from the course and complete the course requirements at a later date, or you will be required to make-up the missed hours. Your situation will be reviewed by the Course Coordinator and Associate Dean, Undergraduate Program.

Requests for absences related to nursing scholarship and service learning will be considered.

Please note that travel/social/recreational activities will not be accepted as reasons for absence.

A medical note may be requested.

STUDENT MISCONDUCT

Plagiarism is a serious offence which will result in the following penalty and application:

- 1. In cases in which the dean and/or faculty is satisfied that a student is guilty of plagiarism, cheating or other academic misconduct in circumstances which suggest a clear intention to deceive or otherwise commit an academic offence, the normal penalty will be either suspension or expulsion from the faculty.
- 2. In cases in which the dean and/or faculty is satisfied that an offence has been committed, but doubt is left as to the existence of a clear intention to deceive or otherwise commit an academic offence, the normal penalty will be probation.
- 3. In cases where a student is found guilty of more than a single offence, the normal penalty will be expulsion from the faculty, and in the most serious cases, expulsion from the University.
